It is especially requested that the particulars as required hereunder are CAREFULLY and ACCURATELY completed and signed by the Funeral Service and the client.

1. Christian name or names, surname and address of person to be buried.	
2. Description (as to Profession, Trade, etc.) of the person to be buried (if a minor, name and address of parents).	
3. Date of birth of person to be buried.	
4. Date of death and place where death occurred.	
5. Date on which the burial is to take place.
