Address: Dukes Mews, Duke Street Princes Risborough, Buckinghamshire

Proposal: Variation of condition 2 (approved plans) of planning permission 25/05396/FUL (Demolition of the existing vacant single storey building and erection of a detached 3 bed dwellinghouse and landscape enhancements to the existing site) to allow relocation of new garden wall and metal railing **The Town Council has no comment**

Address: Winterfold, Askett Lane, Askett, Buckinghamshire

Proposal: Crown reduce by around 1 meter in height and 1.5 meters in spread to a smaller well shaped tree without overhang to roof and patio, dead and crossing growth also to be removed to lessen the crown density and some lower growth to be removed to raise the crown to an even 2.5 meters over the ground to 1 x Apple

Address: Rectory Farm, Princes Risborough, Buckinghamshire

Proposal: Fell 1 x Beech tree (T3) due to bracket fungus and crown lift by 5 meters to 2 x Horse

Chestnut trees (T8 & T11) to clear road and trees are overgrown and branches falling

The Town Council will abide by the arboriculturist's decision but encourages the applicant to consider planting a native species when replacing the tree.

Proposal: Remove to ground level and grind stumps of x 4 apple trees (G1), remove by 6-7 metres x 1 Elder, remove to ground level of x 1 Horse chestnut, remove to ground level of x 1 horse chestnut, remove to ground level x 1 apple (T6), remove to ground level x 1 Conifer, level and trim by up to 1

metre x 1 Conifer hedge and remove to ground level x 1 Horse Chestnut **The Town Council will abide by the decision of the arboriculturist**
