#### 5. A REPORT FROM THAMES VALLEY POLICE

Thames Valley Police (TVP) sent the following report: -

The team has been visiting elderly vulnerable members of the community to check on their welfare and to try to keep their spirits up in these strange times.

Generally, people are still subdued by the threats of the virus so Anti-Social Behaviour (ASB) and crime are low. There are signs that youths are causing a few concerns around perceived low level ASB but this seems to be mostly in rural areas outside the town so its impact is minimal.

The Police are getting a lot of calls around perceived speeding vehicles. Enforcement is an option Police use where statistics back this up but in a lot of cases a referral to <a href="www.communityspeedwatch.org">www.communityspeedwatch.org</a> (CSW) is recommended to see whether concerned members of the public can join a local CSW team and participate in educating drivers around speed related issues.

# 6. A REPORT FROM BUCKINGHAMSHIRE COUNCILLORS ON MATTERS CONCERNING PRINCES RISBOROUGH

Summerleys Road plane and patching has been completed; this is to overcome some of the road being broken up by HGV lorries which has caused immense under surface damage.

Progress is being chased on the upgrade to Picts Lane and the associated footways at its junction with Station Road. High/Duke Street and Market Square resurfacing has been reported to be completed by 31st March 2021. This is unacceptable and needs to be brought forward as the road surface, particularly in the High Street, is breaking up badly.
