THE TOWN COUNCIL PRAYER

5. A REPORT FROM THAMES VALLEY POLICE

Thames Valley Police (TVP) sent the following report: -

A drugs warrant was executed in Princes Risborough on 13th November 2020 resulting in class A drugs, cash and other evidential items being seized. Two adults were arrested and the investigation is ongoing.

A car was stolen from the Fields estate on 17th November 2020. A male suspect has been arrested and the car has been located and returned. The investigation is ongoing.

The team are aware that there have been some anti-social behaviour (ASB) incidents reported in town in recent weeks and we are patrolling the identified locations and engaging with local youths in an effort to identify suspects and reduce ASB.

The newly adopted Local Plan for this area does not allocate this land for residential or traveller use.

17. LIME TREES AT THE KGV PARK
