Appendix 1

A REPORT FROM THAMES VALLEY POLICE

A new PCSO Carina Gomes da Costa working from Princes Risborough is being trained by PCSO Roger Brooks who will take over from Roger when he retires at the end of the year.

The Hazelmere police office has been closed so the 4 members of staff have moved to Princes Risborough. They are still covering the Hazelmere area primarily but will provide additional Police patrols and resilience to the town and surrounding villages which will be of benefit to local residents.

Crime wise there has been a slight increase in reported anti-social behaviour in the town especially in the parks. PC's Ralph and Churchill did speak with and warn two youths in the new shelter on the King George V park on the evening of Fridav 21/9 for littering.

A resident has been issued with an Acceptable Behaviour Contract.

Appendix 2

A REPORT FROM CLLR BENDYSHE-BROWN (BCC) ON MATTERS CONCERNING PRINCES RISBOROUGH

Bledlow Recycling Centre

There has been an outcry from local residents regarding the closure. The impression was that B.C.C. would build a new Centre before they closed the existing one. This is not now the case. An online petition objecting to the proposal has been set up which has gained some 2,800 signatures. In addition, paper copies have been placed in strategic shops in the town. The Princes Risborough Town Council Chairman has been asked to arrange a date and time for the Cabinet Member, Bill Chapple to come and listen to local concerns.

Picts Lane

It has been promised that the repairs will commence shortly.

Parking Phase 2

Kirk Adams is being chased to have a first meeting.

Mill Lane/Cadsden Plough

Repairs to the Mill Lane footway and Cadsden Road to the Plough are due to commence shortly.

HS₂

A meeting is awaited with B.C.C. to commence talks on mitigation measures for our roads and close by buildings, including Monks Risborough School.

High/Duke Streets drainage

Pressure is being applied to get the proposed implementation measures off the ground before the winter rains set in.

Appendix 3

A REPORT FROM WYCOMBE DISTRICT CLLR A TURNER (WDC) ON MATTERS CONCERNING PRINCES RISBOROUGH

The Local Plan public hearings were held earlier this month with a final day of representations this Wednesday before the Inspector sets about considering all of the submissions and decides whether the Plan is "sound". The sessions which were allocated for discussion on Risborough went broadly as anticipated, with those objecting to the plan (RARA, Wake Up Risborough, etc.) arguing for less housing and against a new relief road, whilst barristers acting on behalf of developers pushed for more housing, more sites, higher densities and lower contributions towards infrastructure provision. Planning officers were well organised and generally performed well under considerable pressure. We are anticipating an initial decision from the Inspector late October/early November.

Meanwhile, as the Town Council looks to construct a town centre regeneration strategy, it might be possible be to secure some assistance from a newly appointed Regeneration Officer at W.D.C. More news on this in a few weeks' time.

Car parking charges across the District are currently being reviewed and as these have been pretty much static for the last 10 years it may be that there will some increase, although nothing has been decided as yet.

Still awaiting a decision on the Unitary situation and the uncertainty this delay has created really isn't helpful, not least because we have no idea whether there will be District/Town elections next May or not. In the meantime, we have to assume that we need to prepare for them.

Within the broader sphere of major projects which have the potential to impact on Risborough - East West Rail, the East West Expressway and the Oxford Cambridge Economic Corridor - all are progressing at varying levels of advancement. The Expressway has now been allocated an indicative route, but still lacks vital detail, while a Government announcement on the Economic Corridor is expected by November.

HS2 still looms on the horizon, will it still go ahead, if so when, and how many construction trucks a day will come trundling through Risborough if it does? I wish I had the answers! The A4010 petitioning group remain in close contact with B.C.C. officers in relation to our agreed road mitigation measures through the expert guidance of Jim Stevens, who led our submission to the Select Committee at Westminster.
