An update on the Community Centre extension



building site hoarding surrounding the community centre. There will be a new function room complete with bar and kitchen, which will be a great addition to our town and available for hire (with discounts for local residents and groups). It will provide a wonderful venue for birthdays, anniversaries and many significant life events.

I am pleased to report that work on the expansion of the Community Centre started in March and has continued, despite the pandemic. Just recently the new roof trusses went on and you can already see the shape of things to come.

Due to the proximity of the Community Centre to the Mount, an archaeological dig was required prior to the groundworks being undertaken. Initial work discovered

a ditch that potentially formed part of the Black Prince's Manor. A full archaeological survey took place at the request of Buckinghamshire Council, and was completed in May. The larger dig didn't discover anything of significance, but we will place the final version of the report on our website.

Due to the architectural dig, work on the building project is running nine weeks behind schedule, though we are working closely with Barry Phipps of BEP Building and Paul Morgan our designer to try and reduce the delay.

When completed the refurbished Community Centre will be significantly enhanced. You can see the shape of things to come on the information panels on the

Our Wonderful Open Spaces

As residents of Risborough we know how lucky we are to live in such a beautiful part of the country. With the open fields and countryside of Aylesbury Vale to the west of the Town, and the unspoilt scenery of the Chilterns Area of Outstanding Natural Beauty to the east, we really are spoilt for choice in terms of green space to enjoy; whether for a walk, a cycle or just to take in some absolutely stunning views.

But what about if we take a look even closer to home?

In Princes Risborough itself, we are equally lucky. The Town Council manages our six wonderful parks and gardens from the historic King George V Recreation Ground through to the Stratton Memorial Garden. With each park as unique as it is beautiful, it is the Town Council's responsibility to ensure that these public spaces remain safe, well-tended and maintained, free from litter and generally in wonderful condition.

The Town Council's maintenance team undertakes frequent mowing of the parks throughout the summer months, maintaining trees and hedges within our parks, and daily litter picks to remove any rubbish which has been left behind by visitors. Supported by a dedicated gardener who looks after Stratton Memorial Garden, you can rest assured that our parks and gardens all receive the care that they need and are in kept in the best possible condition for you to enjoy all year round.

September Focus: Earle Mitchell Playing Field: Salisbury Close, Princes Risborough

Located above Salisbury Close and accessed from the Upper Icknield Way, Earle Mitchell Playing Field is a hidden gem. Nestled on the slopes of the Chilterns it overlooks Risborough's rooftops to the north and the Chiltern escarpment to the east. It is a truly beautiful spot.

And for those of us who enjoy a bit of local history...

The Earle Mitchell Playing Field was established in 1960 by District Council tenants of the Fields estate who had formed the Risborough Tenants Football Team. Local tenants Thomas Earle and Harold Mitchell were heavily involved in acquiring the land for the team's new football pitch.

However, given its location off the Upper Icknield Way, the land itself sloped quite dramatically so Thomas and Harold had a lot of work to do to create a playable pitch! With the help of volunteers, the two men moved hundreds of tons of soil and removed all the flints and stones to create the playing field. The fruits of their significant labours can be seen today in the level pitch, the high bank to the left of the entrance and the steep bank which runs down to Salisbury Close.

The football club played at the Playing Field until the late 1980s with Harold Mitchell as the main organiser and manager of the ground's facilities. In 1993 the Town Council acquired the land and took on the running of the Playing Field at the request of Mr Earle and Mr Mitchell, and the Council named it the Earle Mitchell Playing Field in their honour.

To this day the Earle Mitchell Playing Field remains a wonderful asset for the Town; always enjoyed by those who visit. From walkers along the Icknield Way and on the Field itself, to Risborough Rangers' Junior teams, the vision and labours of Thomas and Harold have created an open space to be enjoyed for generations.

Other local parks and recreation grounds:

King George V Recreation Ground:

Aylesbury Road/Wellington Avenue, Princes Risborough

The following facilities are available: large childrens' play area, including zip-wire and skateboard park.

Wades Park:

Stratton Road, Princes Risborough

The following facilities are available: childrens' play area (designed for children under 6 and fenced off), Multi-Use Games Area and a selection of adult fitness equipment.

St Dunstons' Park: Mill Lane, Monks Risborough


The following facilities are available: large childrens' play area (designed for all ages), including 40ft zip-wire, and many other items. This park also has a small toddler's play area. Both play areas are fenced off.

The following facilities are available: childrens' play area, including zip-wire (designed for ages up to 11yrs).



The Democracy Game

The Town Council values its collaborative relationship with all of our schools in Princes and Monks Risborough. With many of us having made numerous visits to the Polling Stations over the past few years, we believed it would be beneficial for our young residents and future voters to understand the importance of participating in the democratic process through our scheme, **The Democracy Game**.

We met with the leaders of each school to outline the scheme:

Pupils at each school were asked to discuss projects that would benefit their fellow pupils and decide on two final projects that could be put to the students for voting.

Thanks to Wycombe District Council we used real ballot boxes and voting booths from the 2019 General Election to enhance the voting experience.

Voting has taken place across all schools and the children and young people seemed to really enjoy the experience of taking part.

Charities in Princes Risborough

The town of Princes Risborough, which includes Monks Risborough, Whiteleaf and Askett, is looked upon by outsiders, and most insiders, as being affluent with little or any hardship. This may be so on the surface, but we know that there are many cases of family and individual hardship lurking below. This has always been the case and so in years gone by wealthy patrons have set up

charitable trusts to assist those in need. These charities are administered by trustees elected to the boards by various institutions, including the Town Council.

In the past, financial aid was given to those known to the parish both in the form of money and goods to enable those in need to have a 'better' life.

The present Charitable Trust, providing funds in cases of medical need, was established in 1988, but owes its existence to one originally set up in 1920 when funds had been raised by public subscription to restore and dedicate the Market House as the town's memorial to the fallen in the First World War. The response had been so generous that a balance remained, and the happy decision was taken to use it to provide a house known as Memorial Cottage held in Trust for the local District Nurse until the late 1970s after which it was no longer required for the original purpose. For some years it served as Headquarters for the local division of St. John Ambulance, but that tenancy came to an end in 2002.

With the approval of the Charity Commissioners, the Trust was amended to allow the property to be let or sold and the rent or proceeds of sale to be applied to medical services for the benefit of the local community.

There are five Trustees, two of whom are appointed by the Town Council and the remainder by the Trustees themselves.

Aims of the Trust

Princes Risborough War Memorial Trust provides support to any resident of the parish, or exceptionally to adjoining parishes, in relation to medical need, where such support is not otherwise readily available. Examples include:

The provision of a wide range of items such as home safety alarm call systems, items of medical and domestic equipment, and mobility aids.

- Services such as home nursing, help with housework, adaptation of homes for those with disabilities.
- Facilities such as periods of rest or convalescence or the temporary relief of carers, assistance with transport costs.

Of course, these charities operate throughout the year and aid those in need on a regular basis, as well as one off occasions.

At Christmas time the charities organise food hampers for families individuals. Last year alone some 35 hampers were delivered to those in need of a bit of extra Christmas cheer.



During the current crisis the Rotary Club of Princes Risborough continues to help those in need and have recently donated in excess of £9000 to local charitable organisations and schools. Princes Risborough Charity

This charity was set up following the amalgamation of several smaller charities that had been operating within the parish, in some cases for many hundreds of years and derives its income from several allotment and field sites around the area.

The land is in the ownership of the Town Council but is administered by several trustees drawn from the parish of Princes Risborough, Longwick and Lacey Green.

The charity receives rents from tenants and holds the money in trust. There are six trustees elected by the Parish Councils of Princes Risborough, Longwick and Lacey Green.

The trustees meet a few times each year and decide where the money is to be spent to the benefit of those who are in need in the parish.

Aims of the charity

Princes Risborough Charity provides support to individuals, organisations, children/young people and the elderly who require financial or practical support as indicated below:

- Christmas Hampers for the elderly and vulnerable or for those with disabilities.
- Food vouchers for those suffering due to loss of employment and this year those affected by COVID-19.
- School uniforms for children attending local schools whose parents find it hard to budget for them.
- Provision of money to Food Banks.

The combined charity administers approximately 35 acres of various pieces of land within the ancient Parish of Monks Risborough. The oldest of the original charities land (now used as the cricket ground at Whiteleaf) was given in 1737 "for the purposes of recreation and exercise". Other land consists in part of allotments which were created in the 19th century to assist people who were affected by the land enclosures. The income from these earlier charities was originally used to provide stockings, clothing, fuel (coal) and medical aid to the poor of the Parish, although this definition has been relaxed/updated by the Charity Commission to allow the current Trustees wider discretion in allocating the funds. The current Charity is enabled to make grants to those in need within the Parish, in the form of individuals, organisations, children/young people and the elderly for the prevention or relief of poverty. The Charity maintains a modest income and can offer small grants, which meet the necessary criteria.

A new way to tackle the issues that matter most to our community

There is a new way to tackle the issues that matter most to our community – through Buckinghamshire Council's new Community Boards. The boards will connect local people, organisations and groups with the council to improve our local areas. The Community Board, which covers the North West Chilterns area, held an introductory meeting on 9 July to start this conversation. Over the next few weeks organisers will be getting people, groups and organisations in the community involved and helping to identify our key priorities ahead of the official launch in September. Everyone is welcome - read on to find out more about what the board will do, how it will work and how you can get involved.

What is a Community Board?

The North West Chiltern Community Board will identify the themes and issues that most need to be addressed for this area and create an action plan to do this, with working groups to

look at specific projects and issues. The board will:

- represent the voices of local people;
- capture thoughts, ideas and suggestions in new ways;
- enable local conversations about priorities;
- identify needs within local communities and work to produce creative solutions;
- explore areas of interest;
- influence how decisions are made and public services are delivered.

How does it work?

Partnerships created in response to COVID-19 are enabling the new Community Boards to quickly get up and running.

All boards have a leader, as well as a coordinator who makes sure local people, groups and organisations feel connected with the boards and the council, ensuring information is shared and views are heard. There will be a mixture of core meetings and

working groups who will focus on a specific issue or local project. Core meetings will agree priorities, allocate funding and feed back on the plan of action. Anyone who wants to get involved won't need to attend every session. You'll be able to read the agendas and minutes online and can participate in the issues that you feel passionate about.

You can join meetings, or take part in a specific priority or project working group. You can complete surveys, take part in polls or share your views.

Who's in the North West Chilterns Community Board?

The chairman for the North West Chilterns is Councillor Gary Hall, who like all of the boards' chairs is a member of Buckinghamshire Council. The North West Chilterns vice chair is Councillor Carl Etholen and its dedicated coordinator is Jackie Binning.
