2024/2025 Precept

Setting the Precept is a very important part of the Town Council's duty and responsibility which affects us all.

The precept is the amount of money collected through your council tax for the Town Council to maintain the services they are responsible for. It will be collected by Buckinghamshire Council on behalf of the Town Council.

Given the current financial situation, after hours of discussion, it has been necessary to leave some of the important projects which councillors would have liked to have undertaken this year for another year. The council felt it would be inappropriate at this time to raise the precept by an excessive amount. Therefore, the precept for 24/25 has increased by just over 7%, with several projects being put to one side for the time being.

The Town Council needs to balance its books just like any sustainable business. Whilst every effort is made to minimise any rise in the precept by constantly striving to find efficiency savings and generating alternative revenue streams, some of the increases in spending are unavoidable.

The Town Council agreed to make reductions in certain areas including the planting of the town flowers and will



look to work with the contractor to see how we can best utilise the budget, to ensure our town looks its very best.

Sadly, we have needed to remove several play equipment items due to them being at the end of their serviceable life. Please be assured that we are attempting to obtain grants to replace them if we can.

Although finances are tight, we intend to continue to provide the level of service to which you are accustomed.



Development of Stratton Memorial Garden

During the 1990's the Town Council was made aware that the Town's cemeteries were almost full and so began a search for a new burial ground site. Over some 10 years 100 sites in and around Risborough were viewed, but for one reason or another none were suitable nor sustainable. The situation came to a head when the existing cemeteries were indeed full and residents needed to seek burial plots in High Wycombe and Aylesbury. It was at this point the late Anne Stratton made the very generous donation of land off Long Hide to the Town Council to create a new burial ground for the Town. Tests were completed and the site proved acceptable. A public Works Loan was obtained, planning permission was gained and work began on Phase 1 which created the attractive memorial garden, inaugurated in 2009, that has enabled so many residents to bury their loved ones in a place of peace and tranquillity overlooked by the Chiltern Escarpment. A mixture of spaces for both burial plots and internment of ashes is available.

Fifteen years later it is now time for the Town Council to start work on Phase 2 of the Memorial Garden, as while we still have plenty of space for the interment of ashes there are limited burial plots available in the current layout. The much larger area of Phase 2 will be focused primarily on burials and it's expected that it should provide a sufficient number of plots for around 30 years or so. Works have already begun and different sections will be completed over the next two to three years.

Our eternal thanks go to the late Ann Stratton for her generosity and community spirit.

Wades Centre Phase II Completed

I am happy to announce the completion of the second phase of the development of the community centre, and thank all the people whose work and time unseen in the background made this possible. We have been able to upgrade the Wades Centre toilets, something that has been wanted for the last decade, so it is pleasing to see this long-term aim completed. We also now have a permanent home for our Town council, so ending our seminomadic existence and saving the council the rental costs of an office. There is still a third stage to be completed in the future which will further enhance the experience of using the centre.

At the same time, we installed solar panels on the roof of the centre, this has been done with the help of a grant from the North West Chiltern Community Board, a process which was made smoother by our Buckinghamshire Unitary councillors. This should lead to future savings on our electricity bills for the current and future generations. It allows future projects to be implemented which will generate further gains and is a small practical contribution to help reduce carbon emissions and maybe save the planet.

A more regrettable issue is the continuing misuse of the disabled parking places at the Wade Centre. Getting out of a car with a wheelchair needs space, a short walk from the Car Park is something we able-bodied people take for granted, but others could find difficult. It is why these places are reserved for disabled drivers; they are a necessity, not a luxury. Therefore, to ensure that these spaces are used for the purpose intended, we have now employed an agency to fine people who abuse it. You might feel lucky and think you can get away with it, that is your choice, responsibility and fault if you get caught.

Dogs in Parks

One of the most common complaints councils receive concerns dogs in parks. Recently, there's been a rise in such complaints for several reasons. The UK has long been a nation of dog lovers, but dog ownership surged during the pandemic, with many first-time owners unfamiliar with the associated responsibilities. At the same time, lockdown led to people spending more time outdoors, increasing pressure on our public parks and green spaces.

To investigate this issue for ourselves, ClIr. Shipley and I took our dogs for a walk around the town's parks. While the dogs we encountered were all well-behaved and controlled, we noticed that many were off their leads in areas where local byelaws prohibit it. However, we also found that much of the signage regarding these restrictions was inadequate, illegible due to age, or outdated. Although we observed some uncollected dog waste, all the bins were functional, and none were overflowing.

The Dog Control byelaws currently in force were established in 1992 and can be accessed on our website. Here's a convenient summary of what they cover.

Moreover, with approximately 2,000 new homes in the planning stage, our town is poised for substantial population growth. So, with social, regulatory, and demographic changes, it's important to consider the needs of those using our parks and recreational areas, both now and in the future. And, given that 32 years have passed since the implementation of our byelaws, now is an opportune moment to reassess them through targeted consultation or perhaps through Neighbourhood Planning.

Neighbourhood Planning is a resident-led process that empowers local communities to directly influence the development and growth of their area. This approach ensures that community-wide needs, such as for parks and recreation, are effectively addressed and incorporated into local planning decisions. A group of councillors and I have been advocating a Neighbourhood Plan for Princes Risborough, and we will continue to do so.

Please 'watch this space' for information about a public consultation on these matters. In the meantime, if you're new to dog ownership or need a refresher on the law, here are the key points to remember.

While partially addressed by other regulations and guidelines, Stratton Memorial Ground, Duke Street Gardens, and Kite Meadows Playground (in Laidler Crescent) are not covered by the existing local byelaws.

In 2014, Public Spaces Protection Orders (PSPOs) were introduced to help Local Authorities tackle anti-social behaviour by preventing specific acts which would not otherwise be criminal offences. However, PSPOs have been criticised for handing too much power to councils. And, whereas Byelaws are enforced via Magistrates' Courts, PSPO violations can result in on-the-spot fines being issued by police officers and authorized council officers.

While most dog owners in our area are responsible, it's evident that both our dog walking facilities and our dog control measures are perhaps overdue for review. Dog owners require safe places to exercise their pets, yet the closest commercial Dog Parks are in Stoke Mandeville and Postcombe.

- Respect local byelaws check park signage and report any issues to the council.
- Always clean up after your dog and use public bins. If none are available, take waste with you to avoid littering.
- Keep your dog on a short lead near roads, shared paths, and around horse riders or cyclists.
- Ensure your dog is never dangerously out of control in public spaces.
- On 'Open Access' land, always leash your dog around livestock, and from March 1st to July 31st, dogs must be on leads even if there are no livestock present.

Community Speedwatch update

The Speedwatch campaign managed to continue through the winter months with only two events being cancelled due to poor weather conditions. However, we will be struggling to manage forthcoming events due to having a very small but perfectly formed team of volunteers and taking people's holidays into account.

Once again I send out a plea for new members to join us, just two times a month would be fine.

Speeding is not restricted to the obvious candidates, here are the Top 10 offending vehicles by make:

We are only allowed to perform Speedwatch sessions during daylight hours which doesn't identify the majority of vehicles speeding into and out of Princes Risborough, we are actively looking at a couple of activities to assist with this.

- 1. Archer strip data (these are the strips that are placed on the road which collect vehicle type/date/time/speed, this data can then be used to prompt TVP to instigate changes such a speed cameras.
- 2. 24x7 low-cost cameras that capture speed/date/time/vehicle reg and report the results to a phone app. We have only recently been made aware of these.

So, please think about volunteering so we can ramp up the number of sessions we can run.
