## **CHAIRMAN'S REPORT**

CHANGE! - Well it's certainly never dull in Risborough and that's particularly true at present. In many ways the Town is currently facing changes and challenges greater than at any time since the 1950's. Some good, some bad, but mostly yet to be seen. The following is a brief review of some of those changes:

The Black Prince public house – an iconic part of the Town for so many years now looks almost certain to be redeveloped for residential use. The old Royal Mail delivery office - now demolished and to be replaced with a Morrisons supermarket and flats. The Baptist Church - has had a major refurbishment and is now ready for the next 300 years of its history! Picts Lane the continuing saga of the housing development by the Railway Station still awaits determination at WDC planning level. HS2 construction traffic through Princes Risborough - the Town Council has now lodged its petition in Parliament against the effects this traffic will have on our roads. New community group - The Monks Risborough Society has been newly established and we wish it well (check out their website at www.monksrisborough.org ). The East - West Rail project - we wait to see exactly how this will affect the line between Aylesbury and Princes Risborough; could it mean an additional track; what will happen to Monks Risborough Halt? Devolved Services - with the County Council facing further unsustainable cuts in government funding they are looking to devolve some service provision to the Town Council (the alternative would simply be to stop providing them at all). Obviously there would be cost implications and the Town Council is currently considering the proposals very carefully. Mill Lane - with two large scale (unpopular) residential planning proposals for Molin's Sports Ground and land adjacent to



Kingsmead it really does feel as though Monks Risborough is under siege. The combined total of the two developments would mean 300 new dwellings, with little or no improvement to local infrastructure. The Local Plan - last but not least- by now you will be aware of the implications the emerging Local Plan has for Risborough, perhaps the biggest challenge by far that we face, and we will do our best to keep you informed as matters progress.

Well there we have it: Change. There is an awful lot to ponder, but I remain convinced that as long as we, the Community, stick together and face our challenges head on we will "ride the storm" and somehow find a way to retain the character of our lovely Town and be all the stronger for it.

## **TOWN REPORT**

As was reported in the last edition of Crosstalk our Maintenance Team has now taken on the grass cutting in the public parks that are administered by the Town Council and this means that we can have our grass mown when it needs it instead of on a contracted date.

As you will no doubt have noticed the flower beds and containers are now filled with summer bedding and we hope that they flourish as well as they did

last year. The maintenance team will be out each day watering and weeding to keep the displays in good order and we look forward to a great display over the rest of the summer.

The Maintenance Team have also been hard at work in other areas, including the painting of over 200 lamp posts in our regular ongoing maintenance plan for our steel posts.

The winter was not so bad this year for damage to our concrete lighting poles and therefore not so many needed to be replaced, although we are considering upgrading these posts to steel ones in a long term replacement programme.

We recently received a very interesting presentation of a new style LED street light, which would significantly reduce our power requirements and offer a more concentrated, brighter and whiter light and we are presently looking into the long term replacement of all our lighting stock in the desire to reduce our carbon footprint and light pollution as well as getting better value for money. The new Junior Play Area in Wades Park was completed on schedule and has been enjoyed by a large number of children and their parents during the spell of good weather that we have enjoyed recently. At the same time the adult fitness equipment was installed in a fitness trail around the edges of Wades Park and this has also proved very popular and is used so frequently that we are having to install grass mats beneath each item to save the wear and tear on the grass.

We are aware of a shortage of seating in the Earle Mitchell recreation area. This could be a suitable site for the donation of memorial benches. If you are interested please contact the Town Council.

Unfortunately we still seem to have some antisocial dog owners who steadfastly refuse to 'poop and scoop' in our parks and on the pavements of the town. We are in liaison with our local police, as under the "Dogs Fouling of Land Act 1996" our local PSCO's have the power to issue fixed penalty notices for dog fouling: Power of an authorised officer of a local authority to give a notice under section 4 of the Dogs (Fouling of Land) Act 1996 (fixed penalty notices in respect of dog fouling). This power (and the 1996 Act) has now been repealed in relation to England and Wales by section 107 and Schedule 5 Part 5 of the Clean *Neighbourhoods and Environment Act 2005. However* the power continues to have effect in respect of any land which remains designated land under the 1996 Act.Paragraph 1(2)(c) of Schedule 4 to the Police Reform Act 2002, Power to issue fixed penalty notices.



The Pound, Askett

The Pound in Askett has recently been rebuilt to its original design and a sign installed to tell people what the Pound is and its history. The Pound was where stray farm animals were corralled until their owners could reclaim them and has long been a feature of Askett.

As the finances of the Town Council will be sorely stretched in future years the Town Committee, which is a high spending committee, is constantly striving

to come up with more effective and efficient methods of working so as to get the most value for your money that we can.

## **LOCAL PLAN**

The initial public consultation on the Local Plan proposals was completed in June and Wycombe District Council (WDC) have been working their way through the responses from residents across the District, (there were over 600 from Princes Risborough). Once this process is finished the responses will be published on the WDC website and all respondents should receive a direct reply. The timescales for the emerging Local Plan have now slipped back and firm proposals will not be made for some time yet. Whilst the current uncertainty is very frustrating, it is important that the process is completed in a manner which will withstand the potential of future legal challenges, (or disqualification, as happened with Aylesbury Vale District's plan). The Town Council expect to have an update for you later this year. When appropriate, we will issue a special edition of Crosstalk to keep you informed, and probably a series of public meetings. Meanwhile, please see below the Town Council's official statement submitted to the WDC Consultation.

## Princes Risborough Town Council's Response to the W.D.C. "Local Plan" Consultation – May 2014

WYCOMBE DISTRICT COUNCIL

Princes Risborough Town Council (PRTC) is opposed to large scale development on the northern side of the Risborough – Aylesbury railway line, as proposed in the draft Local Plan. Development on this land would set a precedent and potentially lead to uncontrolled urban sprawl across open

on this land would set a precedent and potentially lead to uncontrolled urban sprawl across open countryside which is overlooked by the Chiltern Hills, a designated Area of Outstanding Natural Beauty. It is PRTC's considered opinion that all the land from the base of the Chiltern Hills, which extends from the northern border of the Town and lies within Wycombe District, should be re-designated as AONB and/or Greenbelt in order to protect this beautiful countryside for the present and future benefit of all.

Whilst PRTC is mindful of the need for new housing within the Town, particularly for young families, it is against the use of Greenbelt/AONB for such developments. PRTC is also mindful that low employment opportunities in this northern part of Wycombe District and poor road connections on the A4010 in either direction could impact any large-scale development being considered sustainable.

However, the Town Council takes its responsibilities seriously and should, in the worst case scenario, development be considered on land north of the railway line it would be imperative that the necessary infrastructure improvements, (including, but not exclusively, a western relief road, new primary school, new doctors' surgery and current town centre redevelopment/expansion within the existing commercial centre of The High Street, Duke Street, New Road, Horns Lane and Bell Street), are implemented alongside any housing development. Furthermore, PRTC insist that it should play a key role in all matters relating to any development, including allocation of housing.



PRTC is currently in the process of establishing a Neighbourhood Development Plan to further establish its position.

## **LED LIGHTING**

Many of you will have noticed that the county council have replaced most of the taller lights on the A4010 through Risborough with modern money-saving LED units. The new LED's give a crisp white light and use a fraction of the energy that traditional incandescent bulbs use. They are also individually programmable so that during the small hours when most of us are in bed they can automatically dim by 25% or more, saving even more energy without affecting road users' safety.

The Town Council is now actively investigating a switchover of all our 520 orange sodium 35W and brighter 70W lanterns to low-energy LED's. To switch over to all LED's is a no-brainer as we would consume a fraction of our current energy requirement forever.

Our energy bill for lighting last year was £19,626 so if we can save 30-50% of that every year then we all benefit. To change all 520 in one go would be hugely expensive, in excess of £100,000,



so if we go forward with the project we will probably have to phase them in over a number of years, perhaps 100 per year. The supplier we are in negotiations with has offered to install two sample lights for us to evaluate before we proceed to the next stage (check the website & Twitter for locations). We will of course encourage you all to look at how it performs and give us feedback, more updates in the next Crosstalk.

## **RESIDENTS SURVEY**

The last Crosstalk included a 'residents' survey' questionnaire for us to gather some information on the areas of the town that are our responsibility and to highlight areas that we should concentrate on.

We received over 250 responses from the Crosstalk questionnaire and through the website. Although this does not seem much considering the population of the town and the number of Crosstalks distributed, this is in fact quite a good % response, much better than previous surveys.

The survey concentrated on the Parks and Gardens around the town and also on Town Council communication.

The Town Council are very pleased that respondents were overwhelmingly satisfied or very satisfied with The Stratton Memorial Garden and the 3 major parks of the Town (Wades Park, St Dunstans and KGV) with a staggering 88% being satisfied or very satisfied with KGV. Both The Crescent and Earle Mitchell received fewer responses, being less used than the other parks, but even then, only a very small percentage were unsatisfied with either of these parks. Since the survey, new play equipment and adult fitness equipment has been installed in Wades Park and the Town Council now knows to concentrate any next phase of upgrading on The Crescent and Earle Mitchell.

Play facilities did however come out as the aspects of all the parks that respondents were most satisfied with, with grass cutting coming second and dog waste facilities coming as the least satisfied aspects of the parks. This was a bit of a surprise and now something that we will look at. The Town Council has long since had some concerns about the lack of WDC

dog waste facilities in and around the town, but had thought the parks quite well serviced.

Some of the suggestions received for the parks have been discussed and estimates for some of the work is being sought and considered for next year already. e.g. improved signage to all the parks, more seating and benches etc.

With regard to the general areas of the town, again we were pleased that all of the areas listed as being the responsibility of the Town Council were viewed well. Over 90% of respondents were satisfied or very satisfied with the flowerbeds in and around the town and with the hanging baskets. The town's War Memorials were also rated highly. Of all the listed items, seating areas around the town received the lowest rating (still more than 50% satisfied or very satisfied) and again this is something that the Town Council is now looking at addressing.

We were also pleased that of the responses received regarding the restoration of the Market House, there was overwhelming support for having the work done and the building returned to being the focal point of the town that it should be.

Crosstalk by far proved to be the most successful form of communication for the Town Council with 88% being satisfied or very satisfied with its content. The website, Annual Town meeting and monthly meetings were also all rated well. Visibility of councillors was mentioned as an area for improvement, hence new up-to-date 'headshots' in this Crosstalk and introductions from our new councillors. Some respondents felt they should be more involved and attend our meetings. You are all welcome – meeting details are on the back page of Crosstalk and always published on the website www.princesrisborough.com

Many of the comments received were of issues that the Town Council also shares concerns about but unfortunately has little control over. There were a number of comments relating to the state of the roads and pavements, and of parking issues all over the town. These are areas we regularly address with the relevant authorities and can guarantee are shared concerns and issues that we will continue to push for resolution.

The Town Council are very grateful to all who took the time to respond to the survey. The findings are invaluable in both reassuring us that we are doing the right thing, and in guiding us in the right direction. We will try to publish detailed breakdowns of the responses on the website for more detailed inspection.

#### **GRASS CUTTING**

We know that you are as appalled as we are that Bucks County Council has cut back on the urban in-town grass cutting from 10 cuts per year to 6 (rural from 3 to 2) and that as of early August we have only had two cuts resulting in many areas looking an absolute unkempt mess. We are told by BCC that this is how it will be from now on and rather than looking for improvements we should expect to see the situation worsening as they have to cut back in order to use the funds elsewhere. At the July Town Council meeting the Council decided to agree in principle to accept an offer from the County Council to take on their urban grass cutting within the town from next year subject to further investigation.

Can I make this appeal to all residents - If you have a grass verge outside or near your home and you have previously left this to the county contractors to cut then please consider taking a small amount of your time each month and going out to cut it yourselves. It makes so much difference to your environment. Those of us that do make the effort to keep our verges neat and tidy are rewarded by living in nice looking roads. Many streets in the town look shabby currently purely because of the appalling state of the neglected verges. So please, if you are able go out and do the best you can with the verges, and also if you have a neighbour who can't cut theirs please consider having a go at that too if you have time. I cut the frontages

of 6 properties in my road even though I only have an electric mower and longish extension lead and it certainly makes a difference.

## **POTHOLES**

The Town Council office has been inundated with complaints about potholes within and around our town.



Bucks County Council (BCC) have an ongoing programme of upgrading our existing roads around the town and you will have seen Longwick and Summerleys Roads resurfaced as well as the bellmouths of Willow Way/Manor Park Avenue and Picts Lane/Station Road completely renewed. Bell Street is due to be renewed this August and The Holloway is next to be resurfaced, followed by Aylesbury Road from Tesco roundabout to Queens Road (beside The Paddocks). In addition, the BCC Local Area Technician has identified all those areas which require repair and BCC now has a complete programme of planned repairs. However, BCC have had a very difficult few years with severe weather including snow, ice and this last winter, extreme wet weather. There is only one thing worse on road surfaces than snow and ice and that is water. Our severe flooding in Mill Lane is one of 50+ sites across the county which experienced such problems and Transport for Bucks, the Bucks County Council (BCC) contractor, is working throughout this summer to try and ensure that these do not occur again. To rectify all our roads in Buckinghamshire has been estimated to cost £370m and this year BCC is spending nearly £19m, including an extra £3.75m from government, to try and stabilise this imbalance. Continue to report any areas that you consider need urgent attention.

## **CAR PARKING IN PRINCES** & MONKS RISBOROUGH

There have been many and consistent complaints about car parking within and around both Princes and Monks Risborough. Buckinghamshire County Council (BCC) had originally promised to conduct a review in 4 stages, with the first 2 being completed in 2013 and the second 2 in 2014. This was stated publically at both a Town Council meeting and a local station area public meeting in 2013. However, the officer leading this initiative left the Council without any action having been undertaken. A small subcommittee of Town Councillors (Bill Bendyshe-Brown, Will Streule and Matt Walsh) was formed in June this year

to review the whole of the town's parking areas and this committee came up with known hot spots around the town which was relayed to the parking team



in BCC. A meeting was held in early July with this team and proposals are now being worked up to deliver solutions to our current problems. These include determination of an existing budget within BCC, local public consultations within the known areas, including on line surveys, and then determination of proposals which will again be put to public consultation before enactment. The whole process is planned to be completed within a year - so watch this space for further announcements. The map of known hot

spots is produced above for information, or alternatively visit the Town Council website to see a larger image of this map.

## **PLANNING REPORT**

Wycombe District Council's (WDC) consultation on the Local Plan is understandably still a major interest for the Town Council's Planning Committee although it is so important to the future of the town that it is a full Town Council issue, and consequently the subject of its own article in this Crosstalk.

The Planning Committee is concerned that some of the suggestions within WDC's emerging Local Plan will encourage unwanted speculative applications in the open countryside beyond the railway line and have indeed already had to object to an outline application off Mill Lane. We are also aware of a similar application in the neighbouring parish of Longwick. Molins' current attempt to prepare plans for development of their land on Mill Lane have also caused much local concern and although not in the open countryside at least this site has the protection of being in the AONB and within the Green belt.

There will inevitably be more consultation and public meetings on the Local Plan and we have now a dedicated page on the website for this, so please keep an eye open and get involved. It is important that as a town we have as much say as possible on our future.

Despite this expected growth of the town (and especially with the local, welcome and imminent (?!) development off Picts Lane (glad I have not held my breath!)) WDC have unfortunately approved the demolition of The Black Prince on The Wycombe Road. The Town Council fought to retain this as a pub knowing that a number of parties were interested and even tried to have the building classified as a 'community asset'. Apparently it had not been used as a pub recently enough to be classed as a 'community asset' and despite Town Council's and local residents' objections, WDC could find no reason to refuse the site's conversion to flats. Although they refused the application with regard to the out of keeping design, the principle for residential now stands. With the old Sorting Office now demolished to make way for a Morrison's Local with flats above, the prominent landmarks of the route through the town are quite rapidly changing.

The Town Centre however is thriving with fewer closed shops than ever. In fact nearly all those shut now have plans and both a wine bar, and a tea shop are currently being prepared for opening in Duke Street. Birtchnells is high on the Town Council's list as a shop that is desperately in need of a new lease of life as it is rapidly becoming an eyesore but also one that has been the subject of many rumours – I eagerly await the next one.

As ever, all planning applications received for the parish appear on the TC website where they are easily linked to the relevant pages on the WDC planning website.

On Friday the 12th of September Princes Risborough will echo to the sound of the Peloton as stage six of this year's Tour of Britain cycle race flashes through the Chilterns on its way from Bath to Hemel Hempstead. The Tour of Britain is now in its 11th edition and this year the event has been upgraded to a 2.HC category race. It will be an opportunity to see some of the world's best cyclists close up as nine UCI Pro Tour teams are expected to bring their big guns to contest the race. Previous years have seen

#### **UPDATE FROM WYCOMBE DISTRICT COUNCIL**

WDC have recently made changes to the Horns Lane and the Mount Car Park. The new system involves the use of ANPR (Automatic Number Plate Recognition) cameras which identifies the vehicles on arrival and passes this data to the pay terminals for people to pay on departure. No need to rush back, no fear of receiving a parking ticket! On return, just enter your vehicle registration details on the pay kiosks and it calculates how much to pay. This provides a much better parking experience and allows people to extend their stay longer if they want to. However, if you are a holder of a Blue Badge, please note bays are now marked as being chargeable, but FREE if the badge holder registers directly with WDC.

## WILDLIFE MEADOW STRATTON MEMORIAL GARDEN



Following the hay cut earlier this year, the wildlife meadow at the Stratton Memorial Garden is now benefiting from the relatively dry and wonderfully sunny spring and summer.

Following another magnificent display of cowslips during April and May, the current plant that dominates the meadow is the stunning Horseshoe Vetch. Large patches are now established as part of our work to reduce coarse grasses. Importantly this vetch is the preferred nectar source for a wide range of insects including the dazzling Common Blues which now have a foothold in the meadow along with a growing number of recorded birds, insects, mammals and plants.
