1. TO RECEIVE AND NOTE APOLOGIES FOR ABSENCE

Members were asked to declare any pecuniary or non-pecuniary declarations of interest and the nature of that interest which they may have in any of the items under consideration at this meeting.

4. PUBLIC FORUM

No members of the public were present.

5. NOTIFICATION OF APPLICATION REFERENCE PL/25/2328/RM

A notice of application has been received to install a 20m monopole and ancillary equipment on green space between Hawthorn Road and New Road, Oak Road.

Buckinghamshire Council invites comments via the website before the deadline of 22nd August 2025.

Cllr A Ball proposed that the following points be included in the response to the Planning Department. Seconded by Cllr A Turner.

- The Town Council supports the comments made by Buckinghamshire Council regarding the visual impact and the location in an area designated as green space, adjacent to the green belt.
- The Town Council wishes to add that there will be an adverse visual impact on the Chilterns National Landscape due to the height and associated infrastructure in an elevated location.
- The proposed location is close to Princes Risborough School, Youth Centre, and residential estates, with close proximity to young families.
- The Town Council is supportive of the need for telecommunication equipment in Princes Risborough and would be happy to work with the company to identify a more suitable location within the Town.
- The Council requests a meeting with the telecommunications company, together with a consultation/meeting with residents.

Resolved: that the Town Council's appointed agent be requested to prepare a response to the Planning Department incorporating the above points.

It was further **agreed** for ClIr M Walsh to contact the Chief Fire Officer & Chief Executive Buckinghamshire Fire & Rescue Service to request consideration for the siting of a new 5G mobile mast at Princes Risborough Fire Station, as a replacement for the previous mast on the training tower.
